- 1. Eligibility Criteria: Agencies experienced in auctioning work in government, semi government & private organizations.
- 2. Submission of offer: Agency shall submit its offer in sealed envelope super -scribed as Auction of Scrap/Obsolete/Unserviceable items on "As is where is basis" situated at Gandhi Darshan Complex, Rajghat, New Delhi shall contain the following:-
